The performance of the Fire Fighting System as incorporated in the buildings were tested at random and found satisfactorily working condition. In view of the above this office is releasing the Fire Safety Certificate for occupancy of the aforesaid building.

## Recommendation:

- 1.All the Fire Safety Recommendations/Revised Fire Safety Recommendations which were issued vide this Office Memo No. IND/WB/FES/20192020/85641, Dated:- 28/02/2020 be followed strictly at all time.
- 2.Driveway must have to be kept free of obstruction at all time for EASY movement of fire Appliances. No parking will be allowed on the driveway.
- 3. The interior finish decoration of building shall be made with low flame spread material confirming I.S. specification.
- 4. To eliminate risk of Pire Hazards, Good House Keeping both for insides and outside of the Building shall be strictly maintained.

- 5. Existing Electrical wiring of the whole building shall have to be carefully checked for any damage in and tear in the particularly lines above false ceiling & ducts.
- A fire control room including a close circuit T.V./ Monitor system will have to be installed which will observe all the for the Building.
- 7. The notice of Fire Fighting equipments and Evacuation plan shall be maintained and displayed at all venerable place the Building.
- 8. The Employees and security staff shall be well conversant with installed Fire Fighting Equipments of the building an operate in the event of Fire and Testing.
- 9.Mock Fire practice evacuation drill shall to be performed periodically with participant of all the occupants of the buildin
- 10. Main and meter room shall be protected with Co2 or DCP Fire Extinguishers confirming I.S. Specifications.
- 11. First-Aid Fire Fighting system shall be provided as per I.S. Specification.
- 12.Arrangement shall have to be made for regular checking, testing and maintenance,

  Fire Fighting installation of the Building to keep them in perfectly good working

  Condition at all the time.
- 13.If required the old line shall have to be replaced with new lines the cables shall always be laid in M.S. conduit pip continuously bonded to the earth.
- 14.Periodical Flashing of water in hydrants pipe line shall be made to maintain the efficient working performance of abomentioned system.
- 15. Fire Safety audit to be conducted at regular interval and to be recorded in the fire prevention maintenance register.
- 16.Transformer & switch Gear room (if applicable) shall be protected with CO2 or D.C.P. Fire Extinguisher conforming I Specification.
- 17. Storage of volatile flammable liquid shall be prohibited and the handling of such liquids shall restricted to scien

boratory only.

18. If gas use in the laboratory shall be provided with an approve out side gas shut-off valve conspicuously marked.

19. Chemicals used in laboratory must be kept in separated isolated stores in proper sealed containers. Lab Asst. Must alert for its maintenance during closing by lock & key after class hours for any spillage, Fumes, Loosen carosiveness, acids, main valves for Bunsen Burners etc.

20. Fire Licence shall have to be obtained from the licence section of the department for proposed storing of hig combustible articles and procession with L.P.G., which come under purview of licence section as per Fire service Act-19 (with up to date amendment).

21. This Fire Safety Certificate is valid for Three years and have to be renewed every three years interval from the date Issue of this letter. In every three years Certificate is to be obtained from the Director General, West Bengal Fire Emergency Services, regarding the Performance of all the life & Fire Safety arrangements and installation of the Building

22. Any deviation or changes the building in respect of the approved plan drawing, without prior permission from this off this fire safety certificate will be treated cancelled automatically.
